The federal government, states, municipalities and municipal associations are exempt from all claims for compensation that are made by participants or third parties on the occasion of the event based on statutory liability provisions. Liability claims between drivers, vehicle owners and owners are also insured. The participant is not entitled to satisfy any claims without the prior consent of the organizer. Insurance coverage is provided on a subsidiary basis.
